1. Understanding the Code

3. Responsibility and implementation

As an employee of Norwegian Mooring AS, you shall strive to exercise good judgement, care, and consideration. If you need advice in handling a specific ethical dilemma, you are advised to consult with your manager or other appropriate authority.

4. Caring about people

Norwegian Mooring shall conduct its business in a manner designed to protect the interests of our employees including their health and safety. Likewise, the employees should actively protect and promote the business objectives and interests of Norwegian Mooring AS.

5. Working environment
